CAPTAINS MEETING

April 3, 2017

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at Clubhouse at Grand Bay on Monday, April 3, 2017.

- 1. President Jim Bilek called the meeting to order at 6:30pm. Roll call taken, all teams were represented except for American Japanning and Tendon Manufacturing.
- 2. Meeting Minutes: Minutes from the Captains meeting on March 11, 2017 were presented and reviewed. Motion to accept by Ted Bush, seconded by Jim Bilek. Approved.
- 3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$943.49 in the league's account with approximately \$200 remaining in an account yet to be transferred from former Treasurer Daryl DuBroy. Additionally, Jeff reported spending about \$8 on needed office supplies. All team and player fees should be paid to Jeff on or before April 17th otherwise teams/players are not eligible for any type of league prize. Payments received after April 17th are not retroactive to the beginning of the season, once prizes are awarded they are awarded.
- 4. Handicap Chairman: Chairman David Hill reported and commented on the following:
 - All team rosters have been received except for American Japanning and Tendon Manufacturing. Rosters were due April 3rd.
 - Website updated as much as possible. Still need head-to-head schedule which Scheduling Chairman is still working on. Will also update Officers page with correct information.
 - David reported that since the handicap scoring system only retains 3 years of history 24 players will have several rounds dropped which will cause their handicap index to be recalculated.

- 5. Rules Chairman: Chairman Bob Grosh was not present but President Bilek reported that Bob had nothing to report.
- 6. Schedule Chairmen: Chairman Jim Bilek reported the following:
 - Schedule has been set and confirmed for 2017.
 - Head-to-head schedule is progressing. Every effort will be made to balance the frequency of each team being the first team off each week. An "average" system is being used to make it fair for every team
 - Several different courses are being looked at for the 2018 season, they include Seven Hills, Raintree and Punderson. Jim encourages everyone to submit courses to him for possible future play.
 - Requests have been received from two teams to be granted early tee times for specific weeks. Jim warned he will do his best but the league has 7 weeks where tee times are dictated by 1) a Knockdown, 2) two shotgun starts, and 3) two split tees.
 - Little Mountain contacted Jim about playing there this year but they were told the league already had a set schedule with no openings.

7. Old Business:

- During the last league meeting the following items were tabled for further discussion. Each item was discussed in length during the meeting with the following outcomes:
 - Declaration of Tee Box by Player. Captain Brian Semen made a motion that a player may declare which tee box they intend to play twice per year, once before the season begins and once mid-season. Looking at the league's schedule it was determined the declaration can be at the Captains Meeting prior to the April 24th Open event at Turkeyfoot and the June 24th event at Good Park. Motion seconded by Ray Mach. Approved.
 - Tee Box Restrictions Placed on Players. After much discussion, centered on player's age and index, it was agreed a player may continue to play any tee box of their choice subject to the new Declaration Rule where a player may only change tee boxes twice per year. The captains agreed the Declaration Rule eliminates the "strategic" element that some thought occurred late last year. No motions made for any changes.
 - 5400 Yard Minimum for Front-Tee Players. Discussion was held regarding if any adjustment was needed to the minimum yardage for front tee players. No motions made for any changes. The four new courses for 2017, Shale Creek/Sawmill Creek/Ashland Country Club/Ellsworth Meadows, all qualify with over 5400 yards from front tees.
 - Playoff Format. A motion was made by Captain Eric Sandvick to change the playoff format for <u>2018</u> to seven teams with the first-place team getting a bye and the last four teams playing in some sort of consolation bracket. The idea behind the motion was to provide more emphasis on winning the regular season championship besides adding more money to the prize pool. Motion seconded by Brian Semen. Approved. The structure of the new Playoff format will be discussed and finalized during subsequent Captains Meetings.

8. New Business:

- President Bilek offered his and the League's thanks to John Szopo for the use of the Grand Bay Clubhouse.
- Turkeyfoot is the first event of the year and it will be an Open event. County Fire will be the starters along with Mashies.
- Shale Creek will be the second event of the year and the 1st Match. It will be a shotgun start.
- Mohican Hills will also be a shotgun start and is the 10th Match.
- This year's Knockdown event will be the second last Match of the year and be held at Chippewa. The
 Knockdown was moved up one week because the last Match of the year is schedule at Madison CC
 and given the distance/late start time some teams may not be able to field their best players for
 such an important week.

- Bush Integrated changed the name of their team to Mashies. No other teams indicated a name change.
