CLEVELAND INDUSTRIAL GOLF LEAGUE

CAPTAINS MEETING

July 24, 2017

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at Clubhouse at Grand Bay on Monday, July 24, 2017. Meeting Minutes were respectively taken by Secretary Daryl Smith.

- 1. President Jim Bilek called the meeting to order at 6:31pm. Roll call taken, all teams were represented except for County Fire Protection, Keystone, NetBirdie.com, and OCS Technologies.
- 2. Meeting Minutes: Minutes from the Captains meeting on June 19, 2017 were presented and reviewed. Motion to accept by Tom Kotlarek, seconded by Scott Tench. Approved.
- 3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$10,518.42 in the league's account and submitted a Financial Report. A disbursement of \$265 was made for compensation to the Handicap Chairman/Website Coordinator, David Hill. \$232 was taken in as part of the Good Park Blind Bogey. Treasurer Kregenow reported he is working on a \$2 food coupon for the Brookside Open event. Motion to accept by Scott Tench, seconded by Jim Bilek.
- 4. Handicap Chairman: Chairman David Hill reported and commented on the following:
 - Due to the rain delay at Chippewa and the subsequent shotgun restart of league play not all players reported a start and end times so as such no Play Times will be posted on the website for Chippewa. He did note, however, that all times were within the allowable 4:35 time limit.
 - David reminded the Captains that start and end times are always needed regardless of the circumstances. If necessary, a cell phone should be used to capture a time accompanied by a comment should a stoppage in play occur.
 - A question was raised about on what the protocol should be if one player elects to seek shelter when lightening is seen but the other three players continue to play. President Bilek stated the single should do what is most comfortable for the player, walk off the course and resume play at a point when the threat has passed even if it means the player plays as a single.
 - David commented on what a great job the league is doing on Slow Play penalties since none have been issued for the last two months. However, he did mention there have been 17 No Show penalties.
 - Since Brookside this week is considered a Match event due to the makeup of the Shale Creek washout No Show penalties will be played off.
 - David pointed out there are eligibility requirements for participation in the Playoffs and CIGL Cup. A new player must play in 6 sanctioned events and an existing player must play in 3 sanctioned events. Currently several teams have players that fall outside of the requirements. The names of the players can be found in the Player Stats / Player Eligibility section of the website:

- David also mentioned the Most Improved page on the website has been updated since the league has now progressed beyond the 9th week of league play which corresponds to the minimum number of rounds a player must have for the year to be eligible.

- 5. Rules Chairman: Chairman Bob Grosh had nothing to report.
- 6. Schedule Chairmen: Chairman Jim Bilek reported the following:
 - Jim asked the captains if they would favor an additional week be added to the schedule next year as a Knockdown assuming the league is at 11 teams. All captains agreed.
 - Jim indicated he is trying to add a Cuyahoga County course to the schedule next year since we are the *Cleveland* Industrial Golf League.
 - A Captain voiced a request to have as many events played as a shotgun as possible. Jim indicated all he can do is ask since it is always the course's decision to make based on how many groups they may have scheduled after our league plays.
 - Jim was asked about returning to Mohican next year given the course has been sold. Jim said the league is leaning away from Mohican for 2018 but we still could return if there are any issues with completing the 2018 schedule. Jim did also say the league is planning a 2019 return at this point.
 - Jim commented that with two weeks left to play 9 teams are still vying for 1st place. One team has a record of 7 3, four teams are at 6 4, and four teams are at 5 5. Good stuff!
 - Jim asked the captains to continue to email any scheduling suggestions to him.
- 7. Communications:
 - President Bilek reported a copy of a letter from 1937 referencing the CIGL was received via the CIGL website by the son of the recipient. It was a letter from the Postmaster of Cleveland congratulating a fellow worker for winning the CIGL championship and bringing glory to the Post Office and his fellow workers.
 - President Bilek reported Ashland Country Club was very complementary on the league's recent event played on their course. They again apologized for losing our play dates when they switched computers and hoped that the league would return next year with the promise of \$35 greens fee and early start times.
 - President Bilek thanked the captains for the efforts at Chippewa given the weather delay and how quickly the league was able to organize the shotgun restart. After the round, several players were approached by the course indicating they would like to have the league back next year. For the record the following teams voted to continue play at Chippewa: County Fire Protection, County Engineers, American Japanning, Mashies, NetBirdie.com, xR and Tendon Manufacturing.
 - President Bilek spoke with Eagle Creek and even after their comments regarding the pace of play the course asked the league to return next year. Jim took the opportunity and booked the course for 2018.
- 8. Old Business:
 - None.
- 9. New Business:
 - Games/fees/comments discussed for the Brookside Open/Team Match event.
 - Since Brookside is a makeup for the Shale Creek event Team Match rules will have priority over Open Event rules. If necessary, Match Play Tournament opponents will match cards to determine winner.
 - \$6 2 Man Stableford Net Best Ball Tournament (\$3 per player) A player may enter as many times as they'd like
 - \$5 Skins Game Two classes
 - \$4 Blind Bogey Mandatory
 - Starters OCS and Cleats. Mashies will be helping since OCS has not provided any player to carry out their responsibilities.

- The xR/American Japanning match will move to the 5th position and the Mashies/NetBirdie.com match will move to the 4th position to accommodate players driving together from American Japanning.
- \circ Long drive and Closet to the Pin holes are to be determined.
- Captains have until 5pm Thursday, July 27, 2017 to notify the Handicap Chairman of any tee time additions/changes/deletions.
- Jim Bilek will arrive early to manage the tee markers.
- Floor opened to all team captains to slot their players into their respective tee times.
- Playoffs begin August 19th at Sanctuary followed by Windmill on August 26th. Finals and CIGL Cup will be held September 9th at Brookledge.
- Captain Adam Hill suggested a discussion, via email, about having the team that plays the field each week having the option to playing first versus last. His reasoning is that he believes most teams would give up the need to know if they won or lost to not end up playing as a threesome at the end of the league plus it is a good pace setting option for the league. A couple of comments were made in response including the concern for the first foursome having to keep up with two threesomes and the opportunity for a member of the team playing the field to play as substitute for another team that is short a player. The topic will be tabled until the Winter Captains Meeting.
