CAPTAINS MEETING

March 26, 2018

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at the Clubhouse at Grand Bay on Monday, March 26, 2018. Meeting minutes taken by Secretary Daryl Smith.

- 1. President Jim Bilek called the meeting to order at 6:30pm. Roll call taken, all teams were represented except for Tendon Manufacturing.
- 2. Meeting Minutes: Minutes from the Captains meeting on March 3, 2018 were presented and reviewed. Motion to accept by Tom Kotlarek, seconded by Eric Sandvick. Approved.
- 3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$5,913 in the leagues' account. Expenses were \$240 to BW3 for the Winter Captains Meeting and \$206 to FatCow Web Hosting & Registration Services. David Hill motioned to accept the report, seconded by Ted Bush, Treasurer's Report approved unanimously.
- 4. Handicap Chairman: Handicap Chairman David Hill reported the following:
 - Half of the team rosters have been submitted. Teams have until April 2, 2018 to submit their rosters. They must be emailed to David Hill at Golf.CIGL@Gmail.com.
 - Team fees are due April 16, 2018. \$200 per team, \$50 per player. Failure to pay team fees on time will make team/players ineligible for awards until fees are paid in full.
 - Reminder: Teams can email their lineups to David before each event and he will load them into the computer.
- 5. Rules Committee: Chairman Bob Grosh had nothing to report.
- 6. Schedule: Chairmen Jim Bilek reported the following:
 - Team Schedule should be done soon
 - All courses for the 2018 schedule have been contacted with a few comments/revisions:
 - Chippewa's start has been moved up to 7:22am
 - Sugar Bush's start has been moved up to 7:28am
 - Shale Creek has confirmed the league will have a Shotgun start
 - Madison will have the same fees and times as last year
 - Turkeyfoot has confirmed the league has a 7:24am start time for both events
 - o Brookledge, Eagle Creek, Hawk's Nest have not returned calls yet
 - Boulder Creek has no booking on record even though Jim made it on 7/31/17, Jim will keep the league apprised of situation
 - o Hawthorn will be a Shotgun start Hawthorn has ended their affiliation with Rosemont
 - Chardon Lakes possible Shotgun start
 - Sanctuary possible Shotgun start

7. Old Business:

• Jim Bilek asked if any conversation about extending the 2019 season by one week. Eric Sandvick commented he would be concerned with possible bad weather. Motion made by Jim Bilek to extend the 2019 season by one week to September 21, 2019, seconded by Adam Hill, motion passed 8 for, 3 against.

- Jim Bilek asked if any conversation concerning the reduction of the award for Best Record from \$250 to \$150 since the first-place team receives an automatic bye into the second round of the Playoffs. Motion made by Jim Bilek, seconded by Bob Grosh, motion passed 8 for, 3 against.
- 2018 playoffs will consist of the first place team receiving a bye into the second round. The first round will consist of 6 players for teams in position 2 through 7 and a consolation round of 6 players in position 8 through 11, the 12th place team will be out of the playoffs.

8. New Business:

- Each team was asked if they would be bringing any new players into the league. A complete list will be prepared once team rosters are submitted, recap follows. Motion made by Jim Bilek to accept all new players, seconded by Adam Hill, motion passes unanimously.

- All new players can only submit scores since January 2016 forward to calculate their handicap index.
- Existing CIGL players can only carry three years of scores (2015, 2016, 2017) so it is possible indexes could change when the 2014 scores are dropped for those who play infrequently.
- Match Play qualifier must be one of the first three events and each player must pick his course prior to the playing the course at which he has chosen to qualify.
- Question: Bob Grosh Do we have enough times for the Open events given the addition of a 12th team? Answer: Jim Bilek Has made provisions for 84-88 times at each Open course.
- Question Bob Grosh When do players declare which tee they will play each week? Answer David Hill Designation must be made by April 2nd when all team rosters are due.
- REMINDER: New rule passed at the last meeting where combination of age plus handicap index totaling 75 or more is the criteria for being eligible to play from the forward tees.
