CLEVELAND INDUSTRIAL GOLF LEAGUE

CAPTAINS MEETING

May 29, 2018

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at the Clubhouse at Grand Bay on Tuesday, May 29, 2019. Meeting minutes taken by Secretary Daryl Smith.

- 1. President Jim Bilek called the meeting to order at 6:30pm. Roll call taken, all teams were represented except for DLH and Tendon Manufacturing.
- 2. Meeting Minutes: Minutes from the Captains meeting on April 16, 2018 were presented and reviewed. Motion to accept by Eric Sandvick, seconded by Ted Buch. Approved.
- 3. Finance Report: In the absence of Treasurer Jeff Kregenow, Secretary Daryl Smith reported a balance of \$10,939.69 in the leagues' account which reflects moneys collected from all the teams and from the first open event. Adam Hill motioned to accept the report, seconded by Ted Bush, Treasurer's Report approved.
- 4. Handicap Chairman: Handicap Chairman David Hill reported the following:
 - Since the last Captain's meeting there have been 12 Slow Play penalties, 4 Slow Plan warnings, and 3 No-Show penalties.
 - Reminded captains of the consequences for Slow Play, first offense may be a warning, second offense will cause member to have handicap cut one stoke, third offense will cause handicap to be cut two strokes, etc.
 - Some scorecards are not filled out correctly, cards are being submitted with only
 player initials, no team names, no dates and no times (start, turn, end). David does
 not want to issue penalties but will do so if the cards are not legible and/or submitted
 correctly.
 - President Bilek stressed the importance of tightening up on the reporting of end times on the scorecards. He will penalize anyone who looks at the computer first to determine what time to be entered. Captain Par Shergill commented it could useful as each group plays the 18th hole to make note of the time the group ahead finishes the 18th hole.
 - 6 players have dropped out of the Match Play event. Open slots from the Championship bracket will be filled from the Consolation bracket. Any open slots from the Consolation bracket will be filled with players who entered but did not previously qualify. The intent of these moves is to prevent any forfeits from occurring. This process will be used right up to the 5pm Thursday deadline to submit changes to the lineups.
 - President Bilek also commented the league must keep the pace of league play up otherwise the last groups in the league have no chance of finishing in 4:35. Course operators do watch, particularly at Eagle Creek, and have made comments. Jim will

- ranger hole #4 at Eagle Creek since this has been noted by the course as a problem in the past.
- Captain Eric Sandvick asked what the process is for reporting extenuating circumstances that could lead to a Slow Play penalty. For example, a series of lost balls on #17 causing a group to be more than 15 minutes the group in front of them. David Hill explained the process where the players may enter notes into the computer when reporting the scores. The Handicap Chairman and the President will review the notes, contact the individuals / Rules Committee if necessary, and make a ruling. It is possible that only one person, not the entire group, could be issued the penalty.
- Reminder: Teams can email their lineups to David before each event and he will load them into the computer if received by Thursday evening.
- 5. Rules Committee: Chairman Bob Grosh had nothing to report.
- 6. Schedule: Chairmen Jim Bilek reported the following:

 - Chippewa will continue to be on the schedule
 - Tam O'Shanter Hills will be added to the schedule

 - Starters TBD
 - o Long drive and Closet to the Pin holes are to be determined.
 - Captains have until 5pm Thursday, May 31st to notify the Handicap Chairman of any Windmill tee time additions/changes/deletions. Any deletions from the tee sheet after 5pm Thursday will require the player being removed to have their handicap cut by one stroke at the next event.
 - Jim Bilek will arrive early at the course to manage the tee markers to ensure the boxes are as close as possible to the differences indicated on the scorecard.
 - 6 Flavors / American Jappaning will be the starters at Good Park.

- Knockdown matchups for Brookledge have been determined, check website for times.
 (Website shows Brookledge will have split tee times, THIS IS NOT CORRECT and will be corrected.)
- President Bilek is trying to arrange a Shoot Out Event after the Mohican match, he will communicate the details as it comes together.
- Bob Gross asked about the possibility of bringing gimmies back into the league.
 Opinions expressed indicated no desire to bring it back since it could compromise the Skins game for the sake of not being penalized for Slow Play and it could impact the overall score and outcome of a match.
- Floor opened to all team captains to slot their players into the Windmill Open.
