

CLEVELAND INDUSTRIAL GOLF LEAGUE

CAPTAINS MEETING

June 18, 2018

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at the Clubhouse at Grand Bay on Monday, June 18, 2018. Meeting minutes were taken by Secretary Daryl Smith.

1. President Jim Bilek called the meeting to order at 6:30pm. Roll call taken, all teams were represented except for DLH, Keystone, Mike's Tree Service, NetBirdies.com, StormesGroup.com and Tendon Manufacturing.
2. Meeting Minutes: Minutes from the Captains meeting on May 29, 2018 were presented and reviewed. Motion to accept by Bob Grosh, seconded by Ted Bush. Approved.
3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$10,472.71 in the leagues' account and reflects expenditures of \$200 for the CIGL Cup payout, \$220 compensation for the Handicap Chairman, and a \$50 player refund to Mashies. Par Shergill motioned to accept the report, seconded by Ted Bush. Approved.
4. Handicap Chairman: Handicap Chairman David Hill reported the following:
 - Play times have been good for the year with the times from Eagle Creek being exceptional. No Slow Play penalties were issued since last Captains' meeting.
 - President Bilek offered his thanks to Ted Bush and Jeff Kregenow for acting as rangers at Eagle Creek. Eagle Creek expressed their gratitude for the league's efforts as the course tracked our start, turn, and end times.
 - At our Windmill Open 73 players participated in the President's game, 6-hole Blind Draw, where seven winners were paid a total of \$438 with \$155 to the winner.
 - Warnings were handed out to players where cards were turned in without the mandatory start, turn and end times. Continued neglect will necessitate player penalties identical to those handed out for No Shows or Slow Play.
 - Reminder to captains (or their designate) - It is the responsibility of the Captain to ensure only complete score cards are placed in the folder. Players are placing many other cards in the folder. A complete scorecard is one that has the results of the match with full names, team name, date / times, and signatures.
 - Reminder: Teams can email their lineups to David before each event and he will load them into the computer if received by Thursday at 5:00.
5. Rules Committee: Chairman Bob Grosh had nothing to report.
 - Question was asked about the green stakes used at Brookledge between #2 and #17. The stakes indicate a "natural" area where carts are not permitted. There is no free drop from the area as there is no indication of entitlement on the scorecard.
 - Question was asked about if the white line on the road between #10 and #11 at Windmill indicates an out-of-bounds marker. The line does not indicate OB, treat the road as a cart path and play on.

6. Schedule: Chairmen Jim Bilek reported the following:

- Current schedule:
 - June 23rd Good Park - Straight tee times starting at 6:49a
 - June 30th Chardon Lakes - Straight tee times starting at 8:00a
 - July 7th Ashland - Straight tee times starting at 7:30a
 - July 14th Mohican Hills - Shotgun start at 8:15a
 - July 21st Chippewa - Straight tee times starting at 7:22a
 - July 28th Hawthorne Valley - Shotgun start at 8:00a
- 2019 Schedule
 - Greyhawk wants the league back, will pursue adding the course
 - Will pursue addition of Big Met and Manakiki from Cleveland Metro Parks
 - Will not look to add Sleepy Hollow, too hard for the league
 - Bob Grosh commented he liked ability to play the Metro courses since they are closer to home since the course schedule does have a few “remote” courses
 - There was discussion about adding another “remote” course to the schedule (Firestone Farms, Kensington, Reserve Run, etc.) but only if securing two more Cuyahoga County courses (Big Met, Manakiki, Seneca, etc.).
 - Rick Saunders mentioned Forest Hills, outside of Elyria, as a possibility
 - Jim welcomes all comments about possible courses to play

7. Old Business: None

8. New Business:

- Games/fees/comments discussed for the Good Park Open event.
 - \$6 - 2 Man Best Ball (\$3 per player)
 - \$5 - Skins Game - Two classes
 - \$4 - Blind Bogey - Mandatory
 - Starters - American Japanning / 6 Flavors
 - Long drive and Closet to the Pin holes are to be determined
 - Starters will determine if play will be preferred or not
 - Captains have until 5pm Thursday, June 21st to notify the Handicap Chairman of any Good Park tee time additions/changes/deletions. Any deletions from the tee sheet after 5pm Thursday will carry a No-Show penalty for the player being removed.
 - Jim Bilek will arrive early at the course to manage the tee markers to ensure the boxes are as close as possible to the differences indicated on the scorecard.
- Four new players have been added to team rosters since the last open event. Motion to accept new players made by Ted Bush, seconded by Jim Bilek. Approved

- Player fees for the four recently added new players must be paid in full by Saturday, June 23rd. If payment is not received the team is not eligible for any ball points until the payment is received. This is the same provision that exists prior to the first Open event each year where no team is eligible to earn ball points if not paid in full.
- Teams have until July 4th to request a refund for players on rosters who haven't played nor expect to play this year.
- Tee boxes may need to be moved next year at Eagle Creek. It was discovered Eagle Creek now offers a White/Black hybrid and a Black/Gold hybrid which could be used instead of the White and Black tee boxes.
- A proposal was made and passed after discussion to change the year-end tiebreakers within the final standings. Any places where only two teams are tied in the standings will have their seeding set based on the head to head record between the two teams. If they played two matches (with knockdowns) AND each won one match, the tiebreak will revert to total points. If there are three teams tied for any position in the standings, the tiebreaker will automatically be the total points for the season. Motion made by Jim Bilek, seconded by Ted Bush. Passed 4-2.
- A proposal was made and failed to be seconded after discussion to provide a medical exception for a player and have his index reset based as a new player to the league rather than his historical index. His index would have risen approximately 3.5 strokes based on the six rounds played this year versus his best 10 of 20 historical rounds.
- Floor opened to permit any players to opt to change tee boxes for the balance of the season.
 - Cleats - Dennis Pugliese - Move to front tees
 - Mashies - Tim Harris and Vincent Licursi - Move to front tees
- Floor opened to all team captains to slot their players into the Good Park Open.
