

CLEVELAND INDUSTRIAL GOLF LEAGUE

CAPTAINS MEETING

August 6, 2018

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at the Clubhouse at Grand Bay on Monday, August 6, 2018. Meeting minutes taken by Secretary Daryl Smith.

1. President Jim Bilek called the meeting to order at 6:30pm. Roll call taken, all teams were represented except for Mike's Tree Service and Tendon Manufacturing.
2. Meeting Minutes: Minutes from the Captains meeting on July 16, 2018 were presented and reviewed. Motion to accept by Charlie Fields, seconded by Adam Hill. Approved.
3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$10,221.10 in the leagues' account and reflects expenditures for compensation to the Handicap Chairman / Website Coordinator, payouts for the CIGL Cup (\$200) and receipts from Chippewa's Blind Bogey. Motion to accept by David Hill, seconded by Al Van Valkenburg. Approved.
4. Handicap Chairman: Handicap Chairman David Hill reported the following:
 - Skins money will now be handed out at each Open event instead of during the Captains Meeting. Too many players are approaching the Handicap Chairman asking for their skins money.
 - Skins Game. REMINDER: Skins money MUST be in the proper envelope (spares are in the back of the folder holding the envelopes) and put in the skins box to be eligible for that week's skins game.
 - No Show / Slow Play Penalties. Three players had their second slow play penalty of the year and will have their handicap cut by two strokes. The league also had one No-show at Chippewa and will have his handicap reduced by one stroke until it has been worked off. REMINDER: No-show penalties cannot be worked off during Open Events; however, they will still be assessed against the player at Open Events until such time that the penalty has been worked off in a Team Match.
 - Scorecards: After the Chippewa event 3 cards were submitted with no times, 2 cards were not signed, and 3 extra cards were found in the folder. REMINDER: It is the responsibility of the captain (or their designate) to ensure only completed score cards are placed in the folder. The captains are responsible for making sure six cards representing the results of the match with full names, team name, date / times, and signatures are submitted.
 - Eligibility. It was pointed out the eligibility of all players for the playoffs and CIGL Cup can be found on the website under the Player Stats tab. Two events remain to qualify, this week at Hawk's Next and next week at Sanctuary.
 - Most Improved. The Most Improved Player list has been available on the website under the Player Stats tab since the ninth week of league play. The qualifications for the award can also be found in the same location.

- Laptop. The laptop was left out at Madison, it needs to be put away by one of the last two teams teeing off. It should be taken to the course operator and asked if it can be put behind the counter for safekeeping.
 - REMINDER: Teams can email their lineups to David before each event and he will load them into the computer if received by Thursday evening.
 - Pace of Play. Jim Bilek took the opportunity to remind everyone the courses care about the pace of play and share our results with other courses. Every player on every hole (not just the last 5 or 6 holes) must realize the importance to keep up with the group in front of them since it does impact the groups behind them.
5. Rules Committee: Chairman Bob Grosh had nothing to report.
- Captain Eric Sandvick mentioned the importance of the league to properly communicate the changes the USGA is making to the Rules of Golf for 2019. Jim Bilek said it would be addressed during the 2019 Captain's Winter Meeting.
6. Schedule: Chairmen Jim Bilek reported the following:
- Jim indicated, as the Scheduling Chairman, it is his mandate to add variety to the schedule each year hence the continuing 3 to 4 course changes each year.
 - Received both positive and negative (very vocal) feedback from Hawthorn but the league will not be returning until the ownership concerns have been settled.
 - Agreements have been reached with Big Met and Greyhawk to be part of the schedule for next year. He is continuing to work on adding Manakiki to the schedule as well.
 - Since feedback continues to be very positive about Ashland for both the cost and the course condition it will appear in next year's schedule as both a Match and possibly as a Playoff course.
 - The league will not be returning to Sawmill in 2019 as course ownership is in flux.
 - Jim welcomes all comments about possible courses to play and asked the captains to canvas their teammates for suggestions.
7. Old Business:
- Jim Bilek obtained the \$10 coupons for Boulder Creek and distributed them to the captains in attendance. Tickets for the teams not attending the meeting will be handled out at the next opportunity.
8. New Business:
- Games/fees/comments discussed for the Hawk's Nest Open event.
 - \$6 - 2 Man Aggregate Net 9 Hole Blind Draw (\$3 per player)
 - \$5 - Skins Game - Two classes
 - \$4 - Blind Bogey - Mandatory
 - Starters - NetBirdie and Tendon
 - Long drive and Closet to the Pin holes are to be determined
 - There will be front, regular and back tee markers at Hawk's Nest
 - Captains have until 5pm Thursday, August 9th to notify the Handicap Chairman of any Hawk Nest tee time additions/changes/deletions. Any deletions from the tee sheet after 5pm Thursday will carry a No-Show penalty for the player being removed.

- Jim Bilek will arrive early at the course to manage the tee markers to ensure the boxes are as close as possible to the differences indicated on the scorecard.
- Knockdown schedule are posted on the website with start times based on reverse order of the standings. The event is NOT a shotgun start.
- The first round of the Consolation Playoff (8th vs. 11th and 9th vs. 10th) will be at Windmill and the Consolation Final will be at Sawmill Creek.
- Captain Bob Grosh asked the league look into what should be done if a player needs to leave the course due to a medical reason (ala Jim Miller). He indicated the current rules are too harsh given the circumstances. Jim Bilek said it will be looked into over the winter.
- Floor opened to all team captains to slot their players into the Hawk's Nest Open.

9. Announcements:

- The next meeting will be held at Grand Bay Clubhouse in Brecksville on Monday, September 10th at 6:30pm.
