CLEVELAND INDUSTRIAL GOLF LEAGUE

CAPTAINS MEETING

July 8, 2019

The Meeting of the Team Captains of the Cleveland Industrial Golf League was held at Buffalo Wild Wings Westgate on Monday, July 8, 2019. Meeting minutes were taken by Secretary Daryl Smith.

- 1. President Jim Bilek called the meeting to order at 6:33pm. Roll call taken, all teams were represented except for DLH, Keystone, Lock 15 Brewing, Mike's Tree Service, and Tendon Manufacturing.
- 2. Meeting Minutes: Minutes from the Captains meeting on June 18, 2019 were presented and reviewed. Motion to accept by Sean Jones, seconded by Adam Hill. Approved.
- 3. Finance Report: Treasurer Jeff Kregenow reported a balance of \$11,821.55 in the league's account. The balance reflects funds received from the Blind Bogey at the Good Park Open and the second 36-hole tournament. Expenses were paid to the Handicap Chairman for handicap/web services and a \$50 player refund to 6 Flavors. Jeff reported Dan Wilczinsky from Tendon owes \$4 for Blind Bogey at Good Park. Motion to accept by Ted Bush, seconded by Adam Hill. Approved.
- 4. Handicap Chairman: Handicap Chairman David Hill reported the following:
 - Four players have not played an event this year:
 - Geoff Barnes 6 Flavors
 - Craig Gubbini County Engineers
 - Shawn Jacklitch County Engineers
 - Mat Stuart County Engineers
 - Two other players have not played in a team match this year:
 - Dan Bania American Jappaning
 - o Jim Vollmer Cleats
 - Kudos on the play of Mike Stefko of American Japanning as he has picked up considerably on his pace of play since the beginning of the season.
 - Pace of Play / Play Times David reported a situation at Eagle Creek where the second group of the day had an injured player which caused the group to not finish within the necessary time limits. The captain entered comments into the computer describing the situation. Since the injured player was President Jim Bilek, he recused himself regarding any ruling if a Slow Play penalty would be issued. David conferred with Bob Grosh, Rules Committee Chairman. They agreed only Jim Bilek would be assessed the Slow Play penalty within the group. Regarding the Ashland event, a Slow Penalty was assessed to one group who did not complete their round within the required time limits before it started raining. No penalties were assessed to other groups who had their round interrupted by the rain.

- Team Standings David mentioned the first tiebreaker for two teams tied in the standings is the result of any head-to-head matches followed by team points. If there are three or more teams tied in the standings the tiebreaker is total points.
- Scorecards Warnings were issued after each round for cards not having the totals on the card calculated.
- Play Time Analysis David asked for comments and none were given other than to continue sending the analysis to the captains.
- 5. Rules Committee: Chairman Bob Grosh reported the following:
 - Since Bob was not present at the June 18th meeting when a rule was passed stating a player may not practice on the course the day of a CIGL event he asked for clarity on why it was passed. The comments offered by the captains were: 1) it hurts the pace of play and 2) it does not promote ready golf. Bob pointed out the USGA has no such stipulation other than what appears in USGA Rule 5.5 (see below). Based on the comments and ensuing discussion Adam Hill made a motion to rescind the rule made at the June 18th meeting and have the league follow the USGA rule. Seconded by Bob Grosh. Approved 5 to 2. Following is an excerpt of the USGA rule:

USGA Rule 5.5 Practicing During Round or While Play Is Stopped

- i. While playing a hole and between two holes, you must not make a practice stroke. Stroke: The forward movement of your club made to strike the ball.
- ii. Exception Between holes you may practice putting or chipping on or near the putting green of the hole you just completed and any practice green, and the teeing area of your next hole. But such practice strokes must not be made from a bunker and must not unreasonably delay play.
- iii. Penalty for Breach of Rule 5.5: General Penalty: Loss of hole in match play or two penalty strokes in stroke play. If the breach happens between two holes, the penalty applies to your next hole.
- 6. Schedule: Chairmen Jim Bilek reported the following:
 - Jim said he heard no complaints about Grey Hawk and Eagle Creek so he polled the captains about returning to each course next year and no objections were heard. Jim said he will schedule Ashland for the same week and same rate (\$35) next year. He also mentioned he would like to potentially replace Chippewa with Ashland next April since he heard many complaints about Chippewa's \$55 rate and many positives about Ashland.
 - Jim also polled the captains about using Grey Hawk as a playoff course in 2020. No complaints were heard but a comment was made pointing out DLH plays there every Monday night during the year. Regardless, Jim will investigate the possibility of scheduling it as a playoff course.
 - Jim pointed out both Eagle Creek and Grey Hawk have the same slope and the captains agreed an adjustment to Eagle Creek's slope must be made by the league since Grey Hawk plays much harder than Eagle Creek.
 - Jim mentioned the current rates at Manakiki (\$58) and Big Met (\$46) will probably go up next year which may preclude returning to them in 2020. There is still a possibility of scheduling Seneca next year.

 - Games/fees/comments discussed for the Ellsworth Meadows Open event.
 - \$6 36 Hole Event Last opportunity to sign up for the second 36-hole event
 - \$6 2 Man Modified Stableford Tournament Combined Score Scoring based on each net score (\$3 per player)
 - \$5 Skins Game Two classes
 - \$4 Blind Bogey Mandatory
 - Starters xR and 6 Flavors
 - 8:06am 1st Tee Time
 - \circ Long drive and Closet to the Pin holes are to be determined.
 - Captains have until 5pm Thursday, July 12th to notify the Handicap Chairman of any additions/changes/deletions for all. Any deletions from the tee sheet after 5pm Thursday will require the player being deleted to have their handicap cut by one stroke at their next team match event.
 - Discussion was held and led by Adam Hill regarding how players end times are determined and recorded. Based on the information found in the Time Analysis data, the league had occasions where groups have finished their round 5 minutes behind the group in front of them. Adam believes 5 minutes between groups is generally not possible given the time it takes for four players to hit their approach shots and complete their putting. These potentially inaccurate end times could have a negative impact on the two groups behind them as it may lead to undue Slow Play penalties. Adam suggested having either another player outside the finishing group or another group record/document the end time. This would eliminate the guessing which occurs when a group fails to record an end time. Jim Bilek made a motion to have one member from each group stay behind to advise the next group of their end time. Seconded by Adam Hill. Failed 3 to 4.
 - Floor opened for each captain to slot their players into the tee sheet for the Ellsworth Open event.
